3 PHARMACEUTICAL FORM

Yellow-green to yellow-brown opalescent liquid with an aromatic odour and taste.

4 CLINICAL PARTICULARS

4.1 Therapeutic indications

A.VOGEL ANTI-APPETITE FORMULA is a homeopathic medicine for regulating appetite and assisting with weight loss. In accordance with homeopathic literature, ingredients address water retention, detoxification, lymphatic drainage, healthy metabolism and control appetite.

This product may assist with weight loss when combined with increased physical activity and an energy reduced diet in healthy individuals.

4.2 Posology and method of administration

Posology

Adults (18 years and over):

Take 10 drops 4 times daily.

Special populations

Elderly population:

No dosage adjustment is required for this population.

Paediatric population:

This product is not indicated in patients younger than 18 years.

Method of administration

For oral use only.

Take drops on the tongue, or directly under the tongue, or in a teaspoon of water.

Take 15 minutes before meals.

Do not use continuously for more than 2 months without consulting a registered healthcare provider.

Use continuously for 8 weeks with increased physical activity and an energy reduced diet in healthy individuals to assist with an efficient, healthy weight loss program.

4.3 Contraindications

• A.VOGEL ANTI-APPETITE FORMULA should not be used in patients who have a hypersensitivity to the active substances or to any of the excipients listed in section 6.1.

4.4 Special warnings and precautions for use

• A.VOGEL ANTI-APPETITE FORMULA contains alcohol and should be used with caution by individuals with a sensitivity or intolerance to alcohol.

This product is not intended to treat obesity.

Paediatric population

• A.VOGEL ANTI-APPETITE FORMULA is not indicated for use in patients younger than 18 years.

4.5 Interaction with other medicines and other forms of interaction

4.6 Fertility, pregnancy and lactation
